### Key Findings

#### **MEMBERSHIP**

- » Two-thirds (67%) of clubs are over 80% full when it comes to membership.
- » 40% of clubs have 500 or more adult members and 71% have 250 or more adult members.
- » 56% of clubs have 100 or more junior members and 76% have 50 or more junior members.
- » On average indoor facilities have 76% adult members and 24% junior (U18) members.
- » On average indoor facilities have 138 members per indoor court (median = 98 per court).

#### **COURT BOOKING**

- » 70%+ of clubs had over 80% court utilization during weekday evenings and weekend daytime.
- » 63% of clubs had over 70% court utilization during weekend daytime and 47% during weekend evenings.
- » 69% of clubs state that they can use more indoor courts, with a majority suggesting they need 2 or more additional courts.
  - » Further analysis showed that there was no distinct relationship between the members per court and the need for more courts.
- » During the indoor season, on average facilities charge \$30/hr during prime hours and \$24/hr during non-prime hours.

#### PROGRAMMING

- » 75% of clubs program over 40% of their total available court hours. Court hours allocated to programming continue to increase.
- » 57% of clubs are able to earn at least double the court fee revenue through programming.
- » On average 51% of court hours are reserved for programming junior programs lead the way with 29% followed by adult programs at 22%.
- » 60%+ of clubs had over 80% program enrollment across all age categories.
- » 39% of clubs reported an increase in junior female players, 56% of clubs remained the same and 4% decreased.

#### PICKLEBALL

- » 45% of clubs offer pickleball. Amongst the clubs that offer Pickleball:
  - → 59% have less than 50 pickleball players and 31% have 50 to 100 pickleball players.
  - → 55% use tennis courts with temporary lines to play Pickleball
  - → 90% believe the sport will to continue to grow at their facility
- » Amongst clubs that currently do not offer Pickleball, approximately one third (28%) are likely to offer Pickleball in the next two years.



#### Methodology

- » Invitations to complete the TPA indoor survey were sent to **141 TPA member indoor facilities** across Canada through SurveyMonkey.
- » We received a total of 79 survey responses (59% response rate).
- » After removing incomplete responses, 72 survey responses were used to complete further analysis.
- » Completed surveys were entered into a draw to win a \$300 Gamma Ball Cart.
- » Following the TPA Indoor Survey, additional questions surrounding Pickleball were sent to all 141 TPA member indoor facilities. We received 65 completed responses for the Pickleball questions.

#### A majority of the analysis in this report was conducted through the following two methods:

[1] GROUPING: numerical variables such as members and court utilization rates were organized into ranges and then the percentage of clubs belonging to each range was identified.

[2] YEAR-OVER-YEAR CHANGE: for several variables, clubs were asked to report their change relative to the 2017-18 indoor season. The report shares the percentage of clubs that increased, stayed the same or decreased for certain variable.

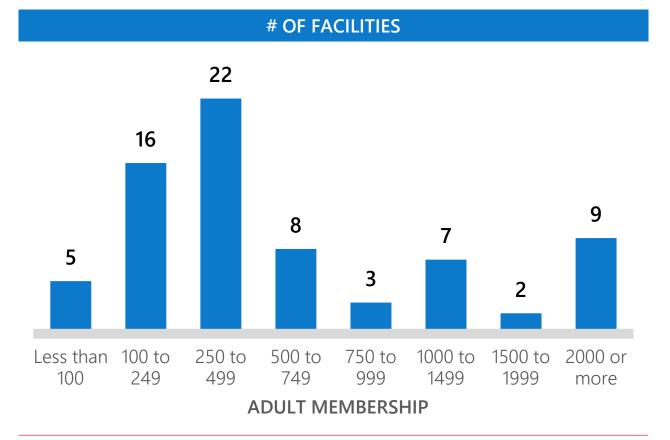

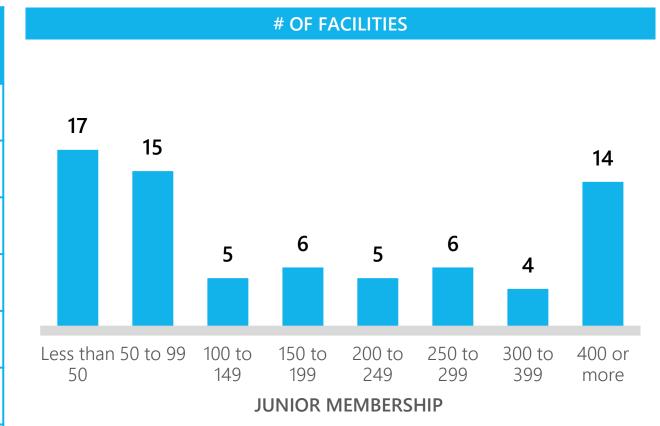

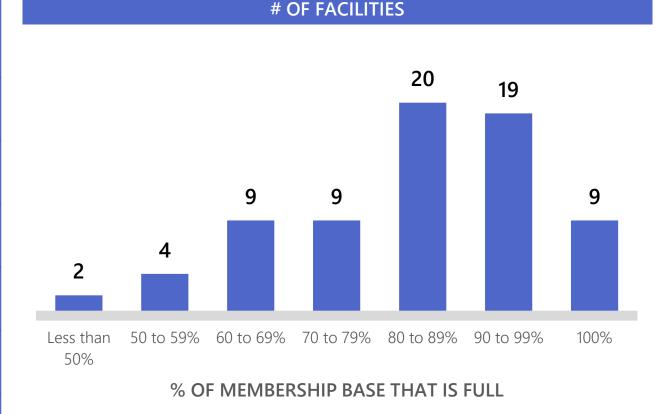

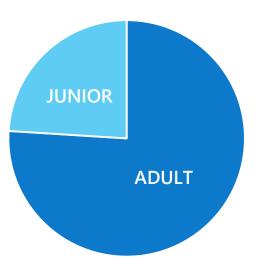

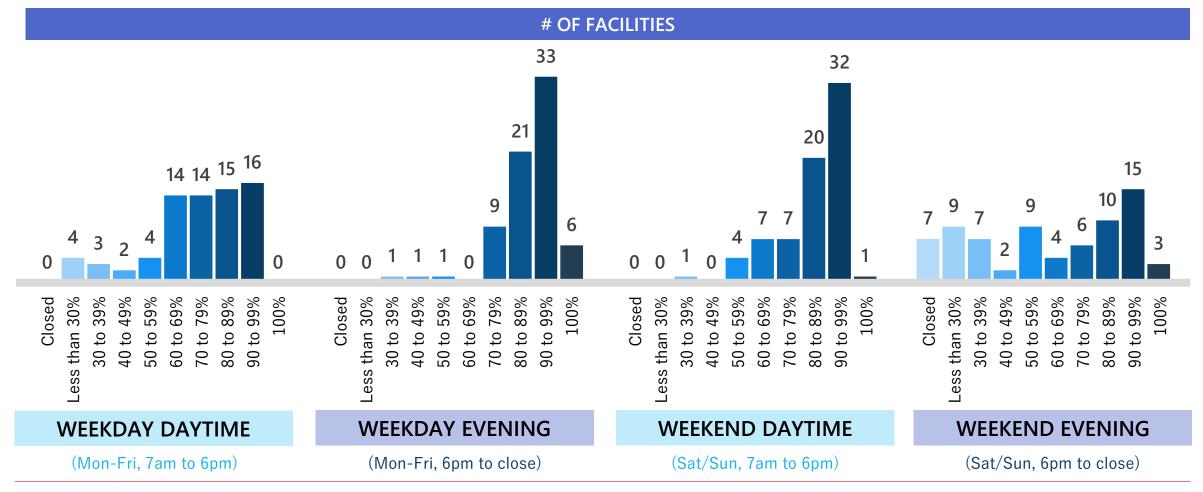

A significant portion of facilities are close to capacity during most operating hours. Weekend evenings appear to be the only difficult time period to fill.



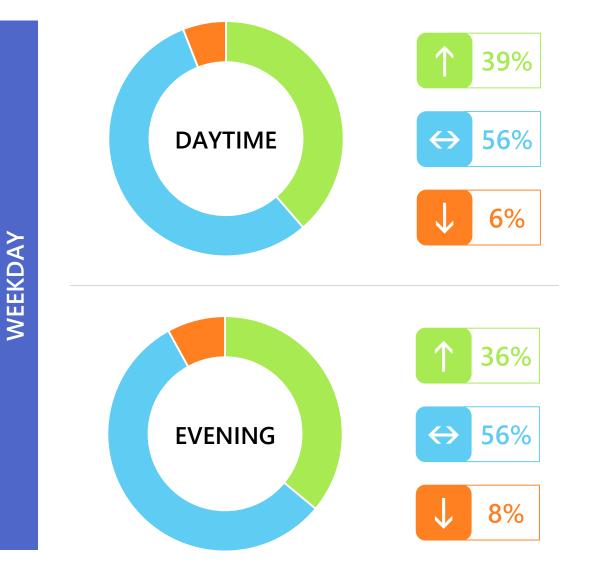

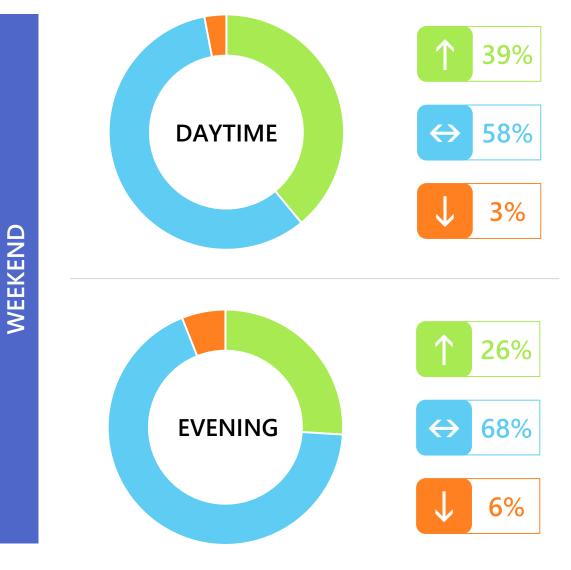

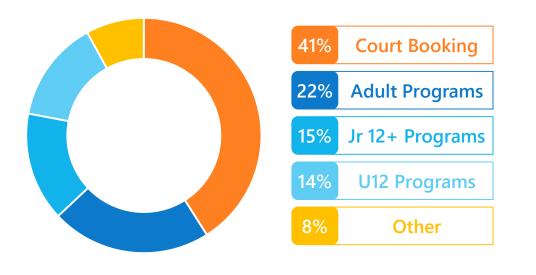

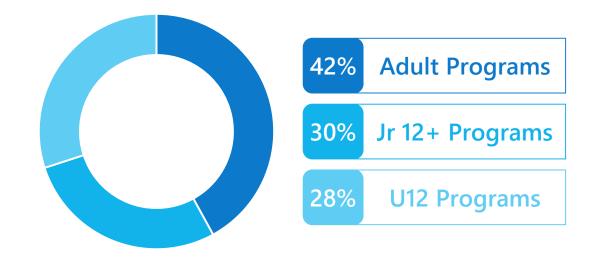

### Average Distribution of Programmed Hours

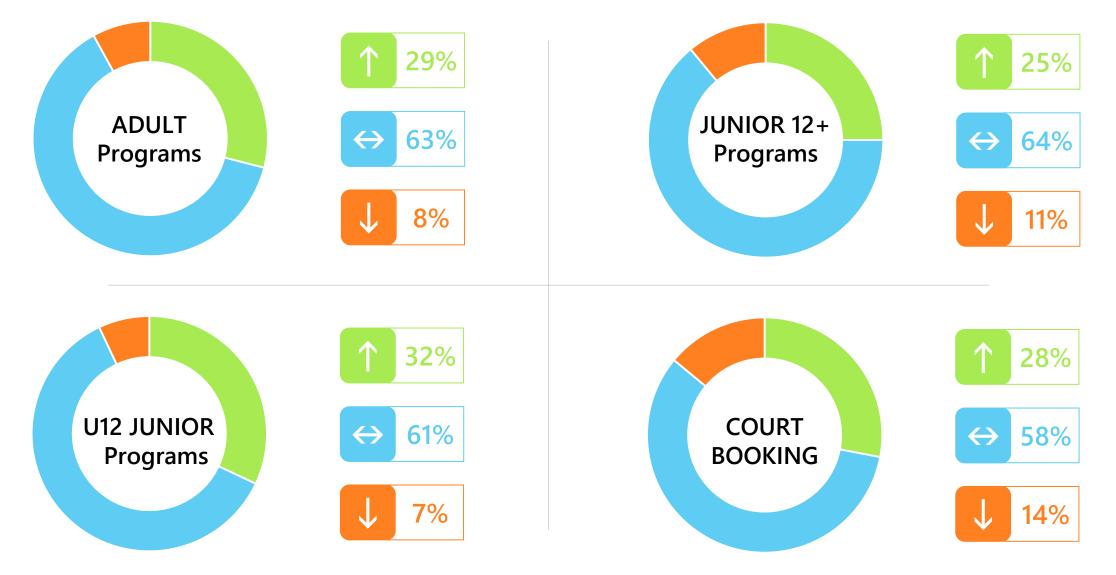


On average indoor facilities program **51%** of their total court hours. On average **41%** of total courts are available for court booking.

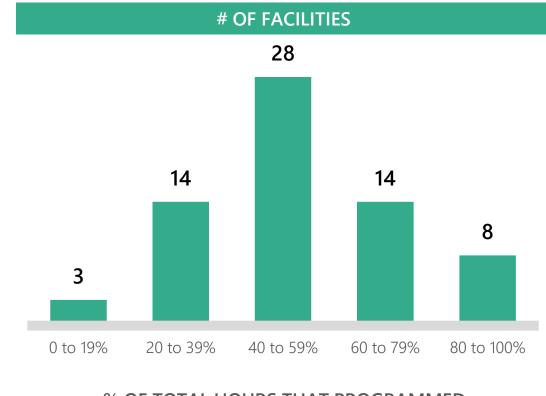

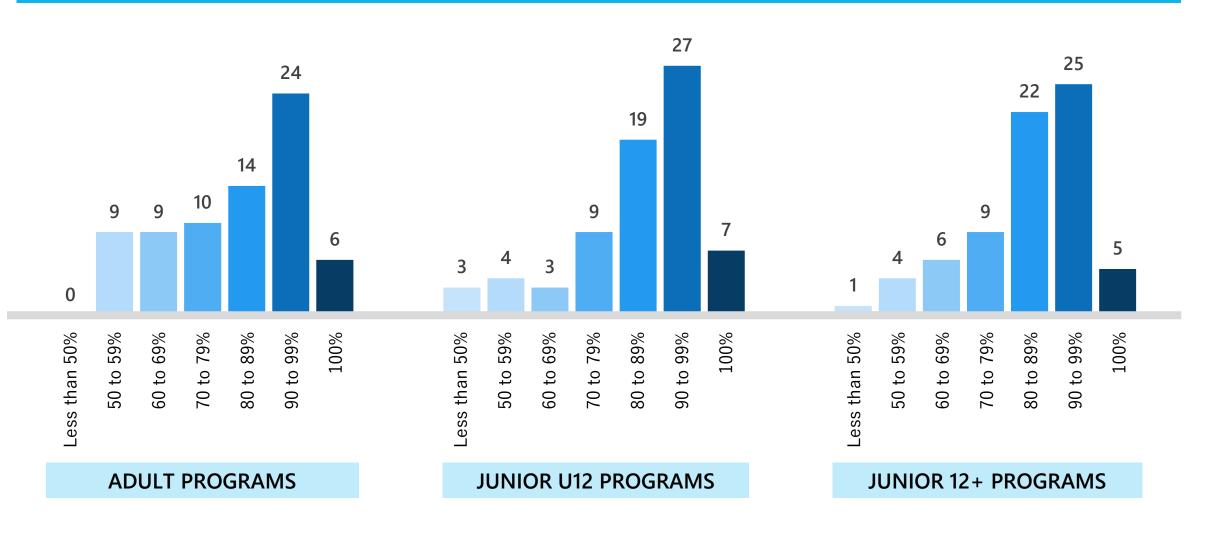

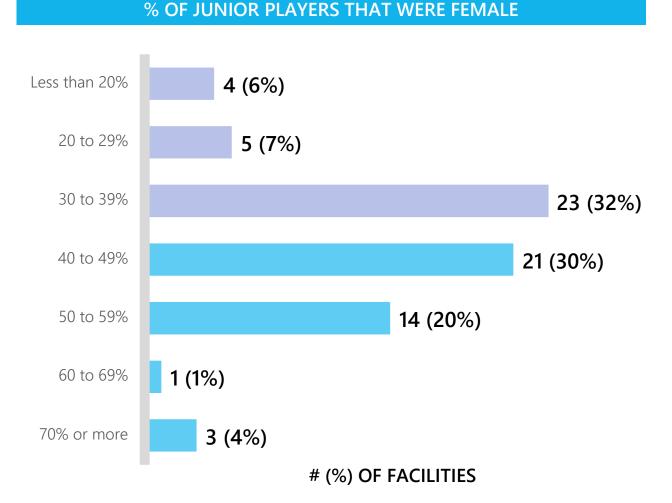

Although females are still under-represented compared to their male counterparts, female junior players increased at 39% of indoor facilities. 54% of indoor facilities have 40% or greater female representation in their junior programs.

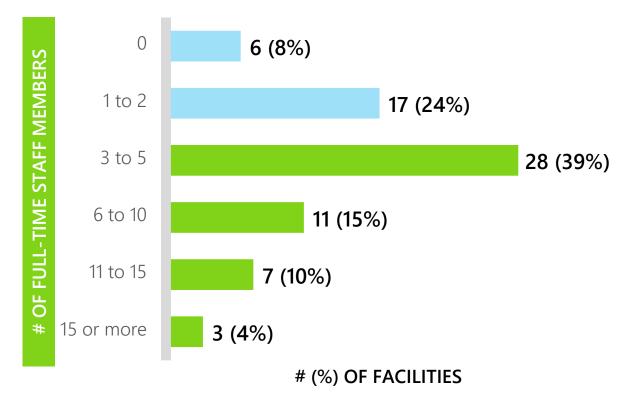

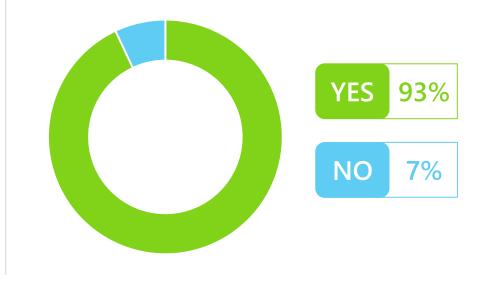


#### Full-time Tennis Staff

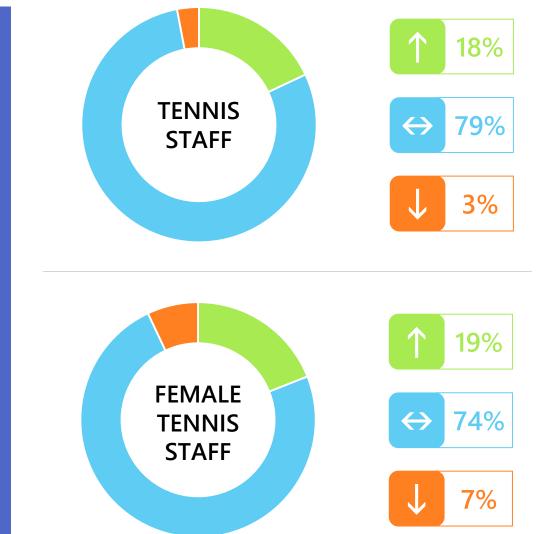
Does your club have policies in place around safeguarding (i.e. background checks)?

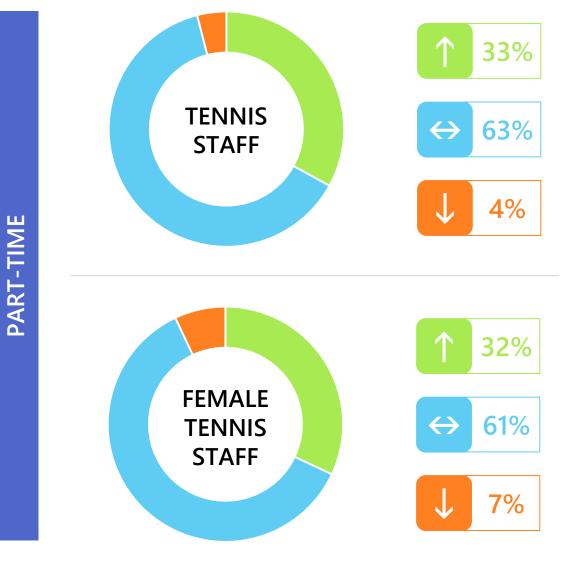


68% of indoor facilities employ 3 or more fulltime tennis staff. **93%** of indoor facilities use background checks to safeguard our sport and its participants.

At **32%** of indoor facilities all FT tennis staff were permanently employed. On average **48%** of FT tennis staff at indoor facilities are permanent (non-contract) staff.



### About the Pickleball Survey

Following the annual TPA Indoor Club Survey, a number of club leaders expressed an interest in acquiring more information about Pickleball and whether (and to what extent) it was being integrated at tennis clubs across Canada.

In July 2019, 141 indoor tennis clubs across Canada were asked about the availability of Pickleball at their facility and their opinions on the future of Pickleball in Canada.

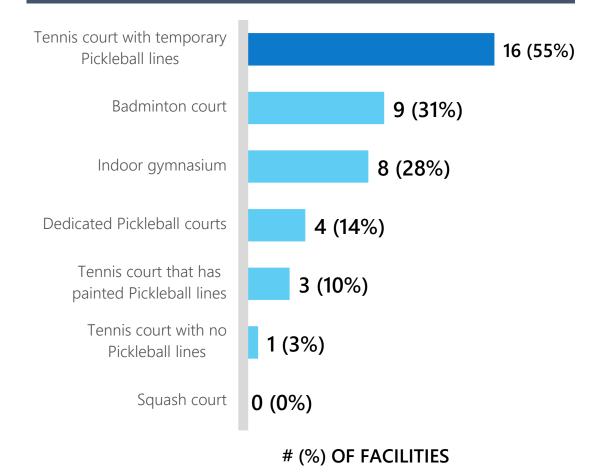
